

2024 Stoddard Polar Bear Plunge Invitational

Hosted by Monte Sano June 1, 2024

This meet will be conducted under the auspices of the Rocket City Swim League (RCSL). RCSL technical rules and regulations will be followed with the exception of items specifically addressed in the meet information. Sanctioned by RCSL.

HOSTED BY: Monte Sano Swim Club MAKOS (MNSO)

LOCATION: Monte Sano Pool - 3609 Georgetta Dr. SE, Huntsville, Alabama 35801

FACILITIES: POOL - One outdoor 7-lane; 25-meter competition pool. Non-turbulent lane lines. Use of audio or visual

recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms. Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and

is prohibited.

SPECTATORS: Green space adjacent common area will be available for swimmers and spectators. Space may be available for

pop-up tents. Chairs will be allowed on deck (such that they do not interfere with conduct of meet).

CONCESSIONS: Will be available.

COACHES: A coaches' meeting will be held Saturday at 8:45 AM near the score table.

RULES: The RCSL ROC will govern the conduct of the meet unless otherwise noted.

Note: Visiting judges are welcome and encouraged to assist. Please notify Greg Wright if you

are interested in working. There will be an officials meeting at approximately 8:30AM.

ELIGIBILITY: A swimmer's age on the first day of the meet will determine his or her age for the entire meet. Age groups for

competition are: 8 & Under, 9-10, 11-12, 13-14, 15-17. The meet may be limited to the first 500 swimmers.

SAFETY: In the interest of safety and accident prevention, coaches and swimmers must observe all posted pool rules and

to conduct themselves in a safe and prudent manner. Please be advised that the depth of the water at

the shallow end of the pool is 3 feet minimum. Please caution your swimmers about the water depth.

WARM UP: The meet director will post and announce the warm-up assignments prior to the start of the meet warm-up.

Racing Dives will only be allowed during the last 10 minutes of warm-up session with swimming allowed in one

direction. Each team must have at least one coach present.

PARKING: Parking will be available at Monte Sano United Methodist and Monte Sano Baptist Church's for the meet. Drop off

will be permitted through the pool parking lot. There will be marked pathway to walk from either parking lot without crossing of any major streets. There will be limited parking at the pool with reserved spots for officials and volunteers for the meet. This will NOT be through the personal yards between the churches and pool, but along side

streets.

All entry fees are non-refundable (unless cancellation for rain in which case in which case only Facility Fee will

ENTRIES:

Swimmers may enter no more than four (4) individual events. The meet may be limited to the first 500

swimmers.

If an entry error is due to an MNSO error, the swimmer will be entered in an open lane of the heat nearest his/her

entry time or in a new heat. The entire event will not be re-seeded.

Entries will be required in HYTEK'S TEAM MANAGER export (and BackUp) format and e-mailed to greg.wright@outlook.com. See below for the deadline for emailed entries. Meet results will be e-mailed to the

address entries are sent from as well as posted on the RCSL website.

ENTRY DEADLINE:

All entries must be received by May 30, 2024 at noon. Entry fees including surcharges must be received by the entries chairperson by beginning of met. Teams should coordinate payment to each team and then one check submitted to Monte Sano from each Club. Please make checks payable to Monte Sano Club.

Once entries are received, a psych sheet will be emailed out to coaches for verification.

representatives. The Referee reserves the right to combine heats and/or events.
